



2025 Q4 Impact Report

The St. Christopher Truckers Relief Fund is a non-faith based 501(c)(3) charity that provides financial assistance for necessity household expenses for over-the road, Class A semi-truck drivers when an illness or injury, occurring within the last 365 days caused them to be out of work and experience financial difficulty.

The St. Christopher Fund also funds free vital preventative health and wellness programs for OTR, Class A semi-truck drivers in the hopes of seeing a healthier driver population. Our health and wellness programs include nicotine cessation, diabetes prevention, chronic disease management, at-home cancer screenings, and a vaccine voucher program where uninsured drivers can get free flu, shingles, COVID-19 and pneumonia vaccines.

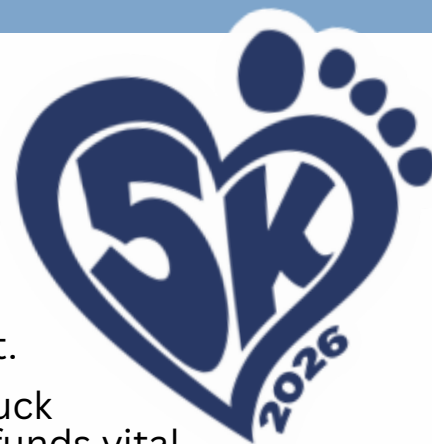

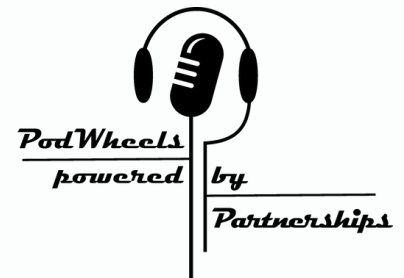
